



C. PROGRESS OF SECTION 1332 WAIVER - General	
<p>12. Provide an update on progress made in implementing and/or operating the approved 1332 waiver.</p> <p>For purposes of 2024 operation, the State-based funding for the program will remain constant at a market-wide \$4 PMPM assessment. Assessments are tracking in line with budget expectations.</p> <p>MGARA reinsurance thresholds for 2024 have been set to a corridor of \$135,000 to \$275,000 with a coinsurance rate of 75%.</p> <p>There has been very limited operational activity in Q1 due to the structure of the program as a retrospective model. Claims submissions for Q1 were predictably very light and not at all informative as regards overall 2024 results. The 2023 final claims submissions are not due until July 20, 2024.</p> <p>Section 1332 grant funding estimate of \$45,726,151 was received May 2, 2024 and is not reported in Q1 results.</p>
